This is with reference to reason for non compliance with minimum (25%) Public shareholding. We wish to submit that presently holding of Govt.of India in equity of the Bank is 87.52% while 12.47% is held by public. Central Government vide notification dt 03-08-2018, in exercise of the powers conferred by Section 30 of the Securites Contract (Regulation) Act, 1956 has deferred the requirement of achieving minimum public shareholding of 25% by 2 years from the date of commencement of the Securities Contract (Regulation) (Second Amendment) Act, 2018 i.e. upto 02-08-2020. We submit that Bank will adhere to all timelines in compliance to regulation 38 of SEBI (LODR) Regulations, 2015 with respect to Minimum Public Shareholding The information is furnished pursuant to Regulation 31(b) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
